

**WEST PASCO ART GUILD, INC.**  
**SHOW RULES AND REGULATIONS**

1. All work must be an original concept and have been performed completely by the exhibiting artist. No painting from paint-along workshops, copies from other paintings, published photos, or painting on photos will be accepted. If found not to comply with these rules, awards will be forfeited. "Published" includes copyrighted photos from the Internet. If an artist is found not complying with these rules, awards will be forfeited.
2. Previous WPAG award-winning paintings are not eligible to be entered in a judged show.
3. An entry (painting, sculpture, ceramic, photo, etc.) may only be shown once during any calendar year.
4. An entry (painting, sculpture, ceramic, photo, etc.) must have been created within the past five years from the date of the show.
5. Entrees must be delivered to the guild on the day of the registration and between the hours specified.
6. All entrees must be priced no less than \$50.00. "Not for Sale" designation is acceptable.
7. All entrees must be clean, properly framed, and securely and suitably wired for hanging. Saw-tooth hangers are not acceptable.
8. All entrees must contain a label affixed to the back containing: artist's name, title of work, medium used, and price.
9. Decisions by the WPAG Show Committee as to where a painting is hung are final.
10. Once an entry has been entered, accepted, and fee paid, no changes can be made. There will be no refunds.
11. Each artist must read, understand and agree to the WPAG Show Rules and Regulations. The artist must sign the agreement found on the entry form. The artist must understand works submitted release the West Pasco Art Guild, Inc. from any responsibility for loss, theft, damages, etc. which may occur. For example, the artist's signature on their work must not be visible and is covered at the artist's risk.
12. Entries must remain in the WPAG gallery for the full term of the show. In the event of a sale, the painting may be removed and the artist is required to place with a comparable piece of art for the duration of the show. All entries for a current show must be removed at the end of the show. If you cannot pick up your work at the scheduled time, it will be stored in the studio at the artist's personal risk.
13. Entry fees must be paid at the time of registration.
14. Prizes will be awarded as follows: 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> places and three (3) merit awards. Honorable mention awards will be made at the discretion of the judges.

15. All exhibiting artists must commit to at least one (1) gallery sitting day for the show at the time of registration. If unable to sit on the designated date, the artist is responsible for arranging for a substitute sitter.
16. Payment of commission to the WPAG, Inc. in the event of a sale will be 20% or as determined by the Board.
17. Entrants are expected to attend the reception for the show they enter.
